INTRODUCTION Welcome

The Training and Cooperation Activity of the of the German Erasmus+ National Agency Higher Education (NA DAAD) "Digital Literacy in teaching, learning and the administration of the Erasmus+ Programme" will focus on two major opportunities of the digitalization of the Erasmus + programme: digital management and the area of "Teaching and Learning". Digitalisation is an overall societal process that presents some risks but also many opportunities. Digital management, summarized under the term "Erasmus Without Paper (EWP)", can reduce administrative burdens and thus create additional potential for further internationalisation and targeted action. In doing so, an overview of the current Europe-wide implementation status of EWP and its concrete implementation will be highlighted based on practical examples from universities.

Digitalisation is also changing teaching and learning at universities, not only, but especially due to the Covid-19 pandemic. This activity will highlight which approaches exist across Europe in learning and teaching and thus provide an up-to-date insight into the "New Normal". Participants will be encouraged to take advantage of the opportunities offered by the Erasmus + programme for new ideas, theoretical concepts and strategies on teaching and learning, thus promoting exchange among themselves. The event will seek to define and develop approaches and strategies for digital literacy and digital skills through discussions, workshops, networking and matchmaking.

Day one will cover digital literacy in higher education administration focusing on *Key Action 1: Mobility of individuals* and targeting university and departmental coordinators, International Office staff, Erasmus coordinators and administrative staff.

Day two will address digital literacy in learning and teaching focusing on all funding lines in *Key Action 2: Cooperation among organisations and institutions* and *Key Action 3: Support to policy development and cooperation* and targeting project coordinators, newcomers and other interested stakeholders. This refers to Cooperation Partnerships, Erasmus Mundus, Capacity Building, European Universities, Alliances for Innovation, Forward-looking Projects, Social Inclusion projects, European Policy Experimentations, Teacher Academies and Jean Monnet Activities.

WORKSHOPS

Day 1

Topic 1: Drivers of change: how legal conditions and modernization agendas shape digitalization

This workshop will shed light on how the legal framework – at European and national level – contributes to the digitalisation of higher education institutions. Furthermore, participants will be asked to share their experiences on the impact of the modernisation agendas on digitialisation.

Topic 2: Change of mindset: digital awareness of processes and intra-university stakeholder communication

Digitalisation is one of the key words of the past decade and a challenge for the whole university. But how does it affect the daily business and how does it change working routines? What should be taken into consideration when talking with other university stakeholders? This workshop will offer an opportunity to reflect and share experiences.

Day 2

Topic 1: How to support educators in the digital transition

The COVID-19 pandemic has led to a sudden and large-scale use of digital learning practices and a signif-icant increase in the demands regarding students' and teachers' digital competences. The range of solutions put in place to ensure the continuity of education and training is wide and includes both low and high-tech practices, with marked differences between regions and EU Member States. In order to make this transition a success for students and for teachers, it is important to support educators in this task. On the one hand, this requires a profound institutional change management, i.e. there is a need for efficient digital structures within HEIs and a clear communication from the university management in order to equip university educators with the necessary structures to fulfill their educational tasks. On the other hand, educators have a responsibility themselves to convey high-quality digital education to students. How can they identify which skills they need for themselves and how they can network/interact with peers to find these solutions. Finally, the question arises which digital learning formats can they offer to students and how can they be enabled to decide which skills students need.

In this workshop, we will hear from KA2 and KA3 project coordinators and practitioners how the digital transition has opened up new possibilities for the teaching practice, how the structural challenges have been met and what support teachers can receive.

Topic 2: Digital education to meet the global challenges

Digitalisation is transforming societies worldwide, providing new opportunities to improve education, to enhance the management of education systems and the development of new innovative teaching meth-ods. The COVID-19 pandemic as well as the other current crises, e.g. the war in Ukraine, have ex-posed the global digital divide and cast a spotlight on the importance of digitalisation. As a global phe-nomenon and with innovation and good practices around the world, the EU has been engaging with partners in third countries.

The speakers of this workshop will provide their experience on using innovative digital tools, embedding them into teaching, learning and assessment and other good practices on digital education in third countries with the help of or within the framework of Erasmus+ funded initiatives and projects. As adaptation to the local context is key to the success of these initiatives, the speakers will share their insights on how to overcome structural barriers to learning and digital skills development, including the importance of digital inclusion.

Topic 3: Fighting disinformation and promoting digital literacy

The rapidly-changing media and information landscape and the diversity of online media platforms and sources of online information offer people opportunities to access information to a whole new extent. While this leads to opportunities related to knowledge development, communication and community creation, the online sphere also presents favourable conditions for the dissemination of disinformation, for hate speech, cyberbullying and radicalisation. Education and training plays a crucial role in equipping citizens with the critical thinking skills required to exercise good judgment online, taking into consideration characteristic phenomena related to the presence of algorithms, 'information bubbles' and 'echo chambers'. This workshop will offer an opportunity to reflect on the key role of education and training in progressing digital literacy among students and young people and equipping them with the right skills and competences to recognise and react to disinformation. Project coordinators will show how handson Erasmus+ projects can support to fight disinformation and how to promote digital literacy
